(ASSAM AMENDMENT) ORDINANCE, 2022

**AN  
ORDINANCE**

further to amend the Societies Registration Act, 1860.

**Preamble**

Whereas the Legislative Assembly of the State of Assam is not in session and the Governor of Assam is satisfied that circumstances exist which render it necessary for him to take immediate action for amending the Societies Registration Act, 1860, hereinafter referred to as the principal Act;

Now, therefore, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution of India in the Seventy-third Year of the Republic of India, the Governor of Assam is pleased to promulgate, the following Ordinance, namely:-

**Short title,  
extent and  
commencement**

1. (1) This Ordinance may be called the Societies Registration (Assam Amendment) Ordinance, 2022.

(2) It extends to the whole of Assam.

(3) It shall come into force at once.

**Amendment of  
section 3C**

2. In the principal Act, in section 3C,-

(i) in sub-section (2), in clause (i), in the proviso, in the second line, for the words "upto one year" appearing in between the words "a society" and "of the expiration," the words "for more then one year" shall be substituted.

(ii) in sub-section (3), in clause (b), in the first line, for the words "fee for delayed filling" appearing in between the words "an additional" and "of application", the words, "fee at the rate of Rupees Two Thousand per year for the period from the date of expiry of the registration till the date of filling" shall be substituted.

**Amendment of  
section 3D**

3. In the principal Act, in section 3D, in the third line, for the words "cease to be a registered" appearing in between the words "it shall" and "society", the words, "become an unregistered" shall be substituted.
